- Participants must weigh 55 pounds or less
- Must be a Logan County Resident
- Each rider will wear a helmet and flack jacket provided by Logan County Fair
- If your child was selected in 2021 they are not eligible for 2022

- **NO** guarantee of participation. **10** entries will be randomly selected for each PRCA rodeo (Thursday, Aug. 4 at 7 p.m. and Friday, Aug. 5 at 7 p.m.) Preference will be given to first time riders.
- Random Selection will be held at the Logan County Fair Office (315 Main Street, Sterling, CO 80751) on Monday, July 11, 2022 at 9 a.m. with notification beginning Tuesday, July 12, 2022.
