



LOGAN COUNTY JUNIOR RODEO ENTRY FORM

1. Logan County Junior Rodeo events open to Logan County 4-H/FFA members only.
2. Contestants must have a project exhibit in competition in the junior division of the Logan County Fair. In the event the contestants recognized 4-H or FFA projects are not in exhibit condition, their completed-to- date project record book must be submitted to the record book superintendent. Such record book must be signed by the contestant's project leader or chapter advisor.
3. Entries must be received on or before JULY 11, 2025.
4. Entry forms are included in this Premium List or can be picked up at the Extension Office.
5. ALL CONTESTANT ENTRY FORMS MUST BE APPROVED AND SIGNED BY THE 4-H MEMBERS CLUB LEADER OR BY THE FFA MEMBERS CHAPTER ADVISOR.
6. 4-H and FFA (age as of January 1, 2025) 8-10 years of age will compete in Junior Division, 11-13 years of age will compete in the Intermediate Division and members 14 and over will compete in the Senior Division events.
7. WINNERS MUST BE PRESENT AT THE SALE RING AT 11:00 A.M. BEFORE THE JUNIOR LIVESTOCK SALE TO RECEIVE BELT BUCKLES AND CASH AWARDS.
8. Entry fee \$5.00 per event. Entry fee must accompany entry form.
9. Members may enter a **maximum of three (3) separate events.**
